We, the undersigned, constituting a majority of the members of the Board of Directors of Fort Bend County Municipal Utility District No. 146 (the "District"), do hereby make, execute and affirm this Amended Information Form in compliance with Texas Water Code §49.452 and §49.455 and 30 TAC §293.92. We do hereby certify as follows:

1. The 2024 tax rate levied by the District on all property within the District is \$0.67 per \$100 of assessed valuation.
2. The total amounts of bonds payable wholly or partly from property taxes, excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity approved by the voters are \$126,000,000 for water, sewer, and drainage facilities. The aggregate initial principal amounts of all such bonds issued are \$59,675,000 for water, sewer, and drainage facilities.
3. The form Notice to Purchasers required by §49.452, Texas Water Code, as amended, to be furnished by a seller to a purchaser of real property in the District is attached hereto as **Exhibit A** and incorporated herein for all purposes.

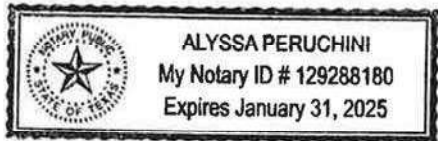

# NOTICE TO PURCHASER OF SPECIAL TAXING OR ASSESSMENT DISTRICT

The real property that you are about to purchase is located in the Fort Bend Municipal Utility District No. 146 (the "District") and may be subject to District taxes or assessments. The District may, subject to voter approval, impose taxes and issue bonds. The District may impose an unlimited rate of tax in payment of such bonds. The current rate of the District property tax is \$0.67 on each \$100 of assessed valuation.

The total amounts of bonds payable wholly or partly from property taxes, excluding any bonds or any portions of bonds issued that are payable solely from revenues received or expected to be received under a contract with a governmental entity approved by the voters are:

- \$126,000,000 for water, sewer, and drainage facilities; and
- \$10,200,000 for parks and recreational facilities.

The aggregate initial principal amounts of all such bonds issued are:

- \$59,675,000 for water, sewer, and drainage facilities; and
- \$6,415,000 for parks and recreational facilities.

The District is located wholly or partly in the extraterritorial jurisdiction of the City of Houston. Texas law governs the ability of a municipality to annex property in the municipality's extraterritorial jurisdiction and whether a District that is annexed by the municipality is dissolved.

The District has entered into a strategic partnership agreement with the City of Houston. This agreement may address the timeframe, process, and procedures for the municipal annexation of the area of the District located in the municipality's extraterritorial jurisdiction.

The purpose of the District is to provide water, sewer, drainage, flood control, firefighting, road, parks and recreational facilities and services. The cost of District facilities is not included in the purchase price of your property.
